HERE ARE THE STEPS:

PLEASE NOTE:

- Any gift planning should be done in consultation with your financial or tax advisor.
- Gift of Securities must have value of \$5,000 or greater.
- Transferring shares between brokerage firms often takes 3 to 4 business days, in which time price fluctuations can occur. Your gift will be valued at the closing price on the day the security is received in our account and you will be issued a charitable tax receipt for that value.
- If you are considering making a gift of shares and would like to receive a charitable tax receipt for the current calendar year, we encourage you to make your transfer on, or before, December 15 to ensure the gift is completed before December 31.
